Is the North American Mid-sized City aModel for Regenerative Urbanism?

Abstract

This paper will discuss precedentsand strategies of regenerative urbanism in the context of the globalenvironmental challenges of the 21st century and will argue that theNorth American mid-sized city may provide a promising model for the future. Thepaper will provide a brief background of North American settlement patterns and contemporary urban and suburban conditions, and their relationship to energycosts and environmental impacts.

It will also summarize contemporaryenvironmental imperatives and sustainable strategies. Currentenvironmental urbanism assessment Report (1987), Kyoto Protocol(1997), reports, (Brundtland 2030 Challenge (2002), Barcelona Declaration on Sustainable Design(2003), An (2006),Inconvenient Truth, and the United Nations IntergovernmentalReport on Global Climate Change - Synthesis Report (Nov. 2007), as well as thescholarship of Gary Coates (Resettling America – Energy, Ecology and Community, 1981), Peter Calthorpe (The Next American Metropolis - Ecology, Community and the American Dream, 1993), Mark Roseland (Eco-CityDimensions – Healthy Communities, Healthy Planet, 1997), and DouglasKelbaugh (Repairing the American Metropolis - Common Place Revisited, 2002), will inform the argument. The paper will conclude with a summary ofspecific case-studies and their implications for future regenerative urbanpractices.
